Amherst Planning Board Annual Report 2023

In the past few years, the Amherst Planning Board has been working on the town ordinances. The Subdivision Ordinance existed in paper form only, and members spent many hours converting it to a digital document.

Work on the Comprehensive Plan revision has been stalled for some time due to a lack of help and a plan for progress on the project.

The Board has been recommending since 2021 that the Amherst Shoreland Zoning Ordinance be changed to comply with state law. The change is minor and requires applicants for a permit to provide "before" and "after" photographs of shoreland vegetation at the construction site along with their permit and follow up report.

The Hancock County Planning Commission has become active and a good resource after several years of absence. The Planning Board recommends that Amherst join the Commission to take advantage of their help.

During 2023 so far, the Planning Board has received from the Code Enforcement officer 7 building permits. The permits were issued for one house, a garage, a shed, a sign for a business, a deck, a camp and an addition to a house. Rebecca Albright is Amherst's Code Enforcement Officer, and she issues permits for routine requests.

The Planning Board has one seat up for replacement this year.

The period of July 1, 2022, to July 1, 2023 saw an increase in the number of serious fires for the Aurora VFD. The house at the end of Richardson Road burned and was a lost cause when we arrived but we were able to stop the fire from reaching two sheds and RV with the assistance of other area fire departments. In addition, we had 4 vehicle fires, three involving passenger vehicles and one involving a motor transport carrying new cars. The transport crash

probably had a total loss close to one million dollars. Miraculously and thankfully, the driver walked away uninjured.

On a positive note, the number of motor vehicle accidents dropped in the last year, which I attribute to the resurfacing of Route 9 in Amherst (eliminating the wheel grooves which collected water and contributed to hydroplaning accidents), the addition of centerline rumble strips and more yellow and black warning arrows on corners on Route 9 which had significant numbers of accidents in the past. Many thanks to DOT for making these changes.

Responding to medical emergencies in the towns of Amherst, Aurora and Great Pond were the greatest number of calls.

The AVFD has 11 volunteer members, three of which are also members of Osborn VFD. Two have fire fighter training, with one member being a FF2, one a FF1, and several with forest fire training. The department has one Basic Emergency Medical Technician and two Emergency Medical Responders. Osborn also has an Emergency Medical Responder.

Besides contracting with Amherst, Aurora, and Great Pond, the AVFD has a contract with Hancock County to provide emergency services for T22 and T28 MD including responses to accidents and other problems on Route 9 east of the Whalesback in Aurora. These townships account for about a half dozen calls a year. We are anticipating more traffic control and "incident investigation" calls on Route 9 due to coverage problems because the State Police are no longer responding to 911 calls. Nearly all responses to incidents on Route 9 will have to be provided by the Hancock Co. Sheriff's office, which is shorthanded, like all law enforcement agencies.

As usual, we need more volunteers willing to respond to emergency incidents and keep the fire department operating. We are paying members for mileage and provide stipends for members for training and other activities.

We have local people who help with grass mowing, snow plowing, cooking for our fundraisers, but we can always use more help in areas like maintaining the station and vehicles. You don't have to be trained in firefighting or emergency medical services to help. All our members are wonderful people who work at making our communities safer and a better place to live.

We would like to recruit volunteers who have a desire to learn new skills and to help in our local communities. We also need people to help run the business aspects of the department like bookkeeping, publicity, administration, fundraising, etc. Others can help by driving vehicles and learning to run the pumps if they aren't physically able to handle hoses and raise ladders. Traffic control is needed at almost all scenes.

Unfortunately, because there are no larger fire departments near our towns, there aren't any alternatives for fire protection that are as inexpensive or able to respond as fast as the Aurora Volunteer Fire Department. As long as the AVFD exists and functions as a fire department, Mariaville and Eddington will respond to our incidents under mutual aid and not charge unless the number of responses become excessive. If the AVFD were to close, the fire protection and EMS response times to our towns could be an hour or more, and the costs billed to the towns.
