The period of July 1, 2023 to July 1, 2024 saw an increase in the number of serious fires for the Aurora VFD. On August 21, 2023, the house at the end of Route 179 burned and was fully involved when we arrived. On May 20, 2024, the house at 23 Old Dam way in Great Pond burned, due to arson. One of our fire fighters, Marie Robbins, owned the house. Her body was found in the fire. The body of her ex-boyfriend, Ryan Devisme, was also found in the fire and the

investigation ruled it a murder/suicide. The loss of Marie, our newest and most enthusiastic member, was a tremendous blow to our department.

Responses to medical emergencies in the towns of Amherst, Aurora and Great Pond are increasing, and we believe it correlates with the aging population.

The AVFD has 10 volunteer members, three of which are also members of Osborn VFD. Two members have structural fire fighter training, with one member being a FF2, one a FF1, and several have forest fire training. The department has one Basic Emergency Medical Technician and two Emergency Medical Responders; Osborn also has an Emergency Medical Responder. Only 3 of these 10 members are under the age of 60. We are in need of younger, capable volunteers to assist in emergency situations.

We need more volunteers willing to respond to emergency incidents and keep the fire department operating. We pay members for mileage and provide stipends for members engaged in training and other activities. Our coverage is particularly thin during regular business hours when many of our members travel to work out of town.

We are recruiting community members to become volunteers. If you are someone who has a desire to learn new skills and to help in our local communities, we need you! Any member can help by doing traffic control, driving vehicles, and learning to run the pumps. We also need help running the business aspects of the department like bookkeeping, publicity, administration, fundraising, etc.

Additionally, we could use more people, membership not required, to help with grass mowing, snow shoveling, cooking for our fundraisers, and maintaining the station and vehicles. You don't have to be trained in firefighting or emergency medical services to help. All our members and helpers are wonderful people who work at making our communities safer and a better place to live.

In a letter previously sent to the town selectmen, the AVFD is requesting a 4% increase in the town quarterly payments, to help compensate for a 10% or greater inflation rate since our last increase in 2022.
