News from the Amherst Planning Board

In 2019, two new members were elected to the Planning Board, Stan Kosinski and Jason Russell. Longtime member Lou Tonerio asked to step down during 2020 because of health reasons. The Board would like to recognize his years of service to the town and local communities. I don't know all his history, but I know when I first came to the area in 1978, he was a member of the fire department and attended many emergency calls as an volunteer Emergency Medical Responder. He has moderated many town meetings as well as served on the Planning Board as a member and recorder of minutes and attendance. He has always done what he could for the local communities as a volunteer. If you get a chance to thank him in person, please do so. If it was not for people willing to volunteer time to our small local towns, we would have no town government or fire department.

The Board will need one new member to be elected at the 2020 town meeting.

The current Board did not meet during the spring due to the COVID situation. Most of the routine town permits are handled by the Code Enforcement Officer. This summer, three of the Board members attended an online webinar given by the MMA regarding Planning Boards. The Board has started work on digitizing the town's Subdivision Ordinance, which now exists only on poor paper copies. If anyone who is good at word processing would like to volunteer to work on this project, we would welcome the help.

The Board needs to continue work updating the town's Comprehensive Plan. Work on the Plan has been stalled since I became Fire Chief and lost my spare time. The Comprehensive Plan is important because Amherst's ordinances are based on the recommendations and goals listed in the plan. Our current plan is outdated (1979) and not in digital form. If our ordinances were challenged in court, the outdated plan may not help to support the ordinances.

We in Amherst are blessed with abundant natural beauty and remote areas that are generally free for public use. Our river and stream resources are particularly unique and valuable. It would be a shame if these resources were lost to development before we had a chance to prioritize their conservation.

The Amherst Land Use Ordinances and permit forms can be found on the web site for the Town of Amherst. Residents are reminded that almost all building projects and earth moving projects require a permit, even if the project is not being undertaken in a protected zone, like the Resource Protection or Shoreland Zones.

The AVFD has 8 active volunteer members, plus two of the members of the Osborn VFD are also members of AVFD. Three have fire fighter training, with two members being FF2s, one a FF1, and two of our members have forest fire training certifications. One other member has advanced hazardous materials training. The department has one Basic Emergency Medical Technician and two Emergency Medical Responders. Osborn also has an Emergency Medical Responder.

This year we did not receive any FEMA grant money. We have an application in process to replace aging extrication equipment and other tools. We updated more of our forest fire equipment utilizing a state forestry grant which pays half of the price.

Hancock County contracts with us to provide emergency services for T22 and T28 MD. Responses to accidents on Route 9 east of the Whalesback in Aurora and these townships account for about a half dozen calls a year.

In 2019 the leaking roof on the older part of the station was replaced with a new metal roof. During 2019, we had a generous business donation from Peruvian Link that supported the tuition for two of our members attending the 2020 Hancock County Fire Academy.

The department also purchased turnout gear for these members at a cost of about \$2,700 each. All firefighters need protective gear and students cannot attend the Academy without NFPA compliant gear (meaning less than 10 years old), plus gear has to be custom fitted to the person. Both students got through the first half of the Academy only to have the Academy shut down in March due to COVID-19. They will be allowed to attend in 2020 for no additional cost, but one of the students has already moved out of state and may not return.

Our most crucial lack at this time, like most volunteer fire departments, is volunteers to fight fires and drive and man the trucks that we have. We need EMS trained volunteers to go to medical calls and support members to direct traffic, assist trained volunteers and maintain equipment and our building. The towns have assisted us by providing slightly higher payments since 2018 for us to work with, allowing us to pay for mileage and more training for members, but now we face a personnel shortage that can't be solved by asking for more funding or donations.

The department has been able to continue through the years because a faithful core group of volunteers would not give up on the idea of helping their communities and providing emergency response within 15 minutes rather than the hour or more it might take other resources to respond. The problem is that these core people are aging and becoming unable to do the "heavy lifting" needed at fire and some medical calls. Most members cannot leave work during the day, so we have very few people available to respond during work hours.

The department desperately needs more members to help cover calls or help with maintenance and administration. We will take help with anything: painting and building repair, truck maintenance, cooking for training and fundraisers, cleaning, etc. Members can help by driving the trucks and learning to pump if they aren't physically able to man hoses and raise ladders. I would also be happy to take names and contact information from people who want to help but not join as a member. However, if someone is not a member, they would not be covered by the protection the department's insurance provides.

Those residents that live within 5 miles of the AVFD station may have an increase in fire insurance rates if the AVFD cannot maintain enough trained firefighters.

A word on COVID 19: So far, our county and rural towns have avoided much of the virus, but this is primarily because the state has been conservative with quarantines and re-openings. Please keep in mind that the virus doesn't care about your political affiliation or personal beliefs about preventative measures, and we have many older people and people with chronic health problems in town that are at serious risk. If one person at a place of business in town became infected, the virus could spread rapidly through our working population. So please, practice social distancing and wear a mask when you cannot distance.
