The AVFD has 12 volunteer members, four of which are also members of Osborn VFD. Three have fire fighter training, with two members being FF2s, one a FF1, and one with forest fire training. One other member has advanced hazardous materials training. The department has one Basic Emergency Medical Technician and two Emergency Medical Responders. Osborn also has an Emergency Medical Responder.

Hancock County contracts with the AVFD to provide emergency services for T22 and T28 MD. Responses to accidents and other problems on Route 9 east of the Whalesback in Aurora and these townships account for about a half dozen calls a year. IN 2022, the contract with Hancock County was re-negotiated to increase payments to compensate for the 7% inflation which has occurred since 2019 when the first contract was signed. In 2022, the AVFD will be asking the towns of Amherst, Aurora and Great Pond for a 5% fee increase to help compensate for the rise in inflation we are experiencing.

Our most crucial lack at this time is volunteers willing to respond to emergency incidents and keep the fire department operating as a business as well as a fire department. We are now paying members for mileage and provide stipends for members for training and other activities.

We would like to recruit younger people willing to learn new skills and a desire to help members in our local communities. We also need people to help run the business aspects of the department like bookkeeping, publicity, building and vehicle maintenance, administration, fundraising, etc.

Members can help by driving the trucks and learning to pump if they aren't physically able to man hoses and raise ladders. I would also be happy to take names and contact information from people who want to help with odd jobs but not join as a member.

The amount of work to keep the department going is becoming a strain on the current members. Without new members, the department will not survive. Since there are no large departments near our towns, there aren't any good alternatives for fire protection that are as inexpensive as what Amherst, Aurora and Great Pond currently pay for. Once the department is gone, it will be very hard to replace it.
