The AVFD has 13 volunteer members, four of which are also members of Osborn VFD. Three have fire fighter training, with two members being FF2s, one a FF1, and one with forest fire training. One other member has advanced hazardous materials training. The department has one Basic Emergency Medical Technician and two Emergency Medical Responders. Osborn also has an Emergency Medical Responder. Three of our younger members have resigned since last year, but they were replaced by three more untrained new members.

This year we applied for and received FEMA COVID grant funds which reimbursed us for some personal protective equipment (PPE) we purchased to deal with the COVID epidemic. The amount was 1,270.00. We have an AFG application in process to help pay for turn out and

forestry gear for our three newest members. We have no idea if it will be granted. We updated more of our forest fire equipment utilizing a state forestry grant which pays half of the price.

Hancock County contracts with us to provide emergency services for T22 and T28 MD. Responses to accidents and other problems on Route 9 east of the Whalesback in Aurora and these townships account for about a half dozen calls a year.

During 2019, we had a generous business donation from Peruvian Link that supported the tuition for two of our members attending the 2020 Hancock County Fire Academy. Both students got through the first half of the Academy only to have the Academy shut down in March due to COVID-19. Due to COVID-19, fire academies have not been held in the county. Since 2020, both new members left the department. Peruvian Link also donated to send one of our younger members to EMT class and we are hoping she can complete her final testing in 2021.

Our older fire engine, the 1981 Pierce, has become unreliable because parts to replace the front steering system are no longer available. We have a deposit down on a used 1997 engine that should be delivered sometime this summer.

Our most crucial lack at this time, like most volunteer fire departments, is volunteers willing to train to fight fires and drive and respond with the trucks that we have. The towns have assisted us by providing slightly higher payments since 2018 for us to work with, allowing us to pay for mileage, some stipends for members and more training for members, but now we face a personnel shortage that can't be solved by asking for more funding or donations.

The department desperately needs more members to help cover calls and/or help with maintenance and administration. We will take help with anything: painting and building repair, truck maintenance, record keeping, accounting, cooking for training and fundraisers, cleaning, etc. Members can help by driving the trucks and learning to pump if they aren't physically able to man hoses and raise ladders. I would also be happy to take names and contact information from people who want to help with odd jobs but not join as a member

Also, PLEASE mark your mailboxes or driveways with your street number in large, reflective numbers. You may have done this in the past, but many numbers have fallen off or faded. Please mark both sides of your mailbox. We may have to locate your house or your neighbor's at night in bad weather, so please make it easier for us, or the help you or your neighbor needs may be delayed. Mapping programs help, but they are not always accurate.
